On 3/15/2014, at approx 2:30PM, I was dispatched to the area of Powerline Road and Cypress Creek Road at the Subway reference a disturbance that occurred on the Interstate 95 (SR9) exit ramp to SR870 (Commercial Blvd). When I arrived at the Subway I made contact with a Joy Mack, FL [redacted] Ms. Mack stated that she was cut off by a red SUV and then they both exited on the northbound I-95 ramp to SR 870. When they both approached the Red traffic light, she stated that a White male, approx. 25 yrs of age, wearing a gray tank top, had exited the Red Suv and began to approach her vehicle with his arms out to both sides. Ms. Mack stated that the male was cursing at her and calling her names. She stated to me that the male did not get physical with her and that he may have leaned on her vehicle while yelling at her. Ms. Mack did have video of the incident on her camera. She showed me the video and I was able to identify the vehicle. Ms. Mack was not able to identify the driver as the registered owner of the vehicle (per DAVID picture). While watching the video, I observed the White male approach Ms. Mack's vehicle but did not lean on the vehicle. I observed the male yelling and cursing at Ms. Mack and put up his middle finger at her. While on scene, I observed no damage to the right side of Ms. Mack's vehicle. Ms. Mack stated that she wanted the incident documented due to her wanting to be able to show the Hollywood Police Department that she had been involved in multiple incidents like this. This incident took place in Broward County.
